TERMS AND CONDITIONS OF DRIVING RANGE MEMBERSHIP

1. All Driving Range Memberships are bound by Rules and Terms & Conditions of South Cerney Golf Course Ltd.
2. Membership is valid for 12 months from the date of application.
 - a. The monetary value credited to each card is to be used within this 12 month period.
 - b. Any money remaining on the card after this period will be lost.
 - c. If you wish to renew the membership or add more credit to your card within the 12 month period, the minimum amount is £50. No monetary amount other than this will be accepted
3. A membership will be represented by a card and this is to be used for payment of driving range tokens only.
 - a. The credit on the card cannot be used for payment towards any other goods offered by South Cerney Golf Club..
4. Transfer of Membership – At any point during the 12 month contract, a Silver Membership can be transferred to a Gold Membership, with the remaining credit on your account being used towards payment. A new membership card will be issued..
5. A driving range membership does not entitle the holder to priority use of the Driving Range.

TERMS AND CONDITIONS

1. **South Cerney Golf Course**

- a) *The course is managed by South Cerney Golf Course Ltd*
- b) *The premises shall be located at South Cerney Golf Course, Northmoor Lane, South Cerney, Cirencester, GL7 5QD*

2. **Data Protection**

I agree that all data relating to my use of South Cerney Golf Course can be used by South Cerney Golf Course Ltd

3. **The Company (South Cerney Golf Course Ltd)**

The company shall through its duly authorised representatives manage and operate South Cerney Golf Course and deal with all matters in connection with it.

4. **Acceptance**

- a) *Upon acceptance of this application the member shall be issued with a South Cerney Golf Course membership card and shall be entitled to all the rights and privileges exercisable by the class of members for which his/her application for membership has been accepted.*
- b) *Membership of South Cerney Golf Course shall constitute a binding contractual arrangement between the company and the applicant upon these terms and conditions of membership and the rules and regulations of South Cerney Golf Course as are from time to time in force.*
- c) *Membership cards issued to all users must be shown when signing in every time a visit is made and produced on request. Cards are not transferable and any other use other than by the member will result in cancellation of that membership with no refund available.*
- d) *An administration charge of £5 is levied for the replacement of any lost cards.*
- e) *Having purchased a South Cerney Golf Course membership package and you do not attend, you will not be entitled to a refund of your fee unless in exceptional circumstances and this will only be at the discretion of the management.*
- f) *All members will agree to abide by the rules and guidelines in place relating to Dress Code, Course Etiquette, Local Rules, Out of Bounds and Staked Trees. These rules and regulations are displayed in the clubhouse.*

5. **Limitation of Liability**

- a) *In consideration for the company accepting his/her application for membership of South Cerney Golf Course, and for he/she becoming and remaining a member of South Cerney Golf Course, the member agrees that:*
 - i. *Neither the company, nor its employees or agents shall be liable for any loss, damage or theft of any property belonging to, our brought onto South Cerney Golf Course premises by the member or any guest of the member, occurring upon the South Cerney Golf Course premises.*
 - ii. *Neither the company, nor any employees or agents of the company shall be responsible for any death, personal injury or illness occurring upon South Cerney Golf Course premises or as a result of the use of the facilities and/or equipment provided by South Cerney Golf Course, except to the extent that such death, personal injury or illness arises from any negligent act or omission of the company or its employee or agent.*

6. **Physical Condition of Member**

- a) *The member warrants and represents that he/she is in good physical condition and that he/she knows of no medical or other reason why he or she is not capable of engaging in active or passive exercise and that such exercise would not be detrimental to his/her health, safety, comfort or physical condition.*

7. **Membership Fees**

- a) *All users of South Cerney Golf Course, have the option of membership or Pay & Play.*
- b) *Upon joining as a member, members shall pay either by a one off annual payment or by direct debit. Annual payments run from May 1st, with pro rata payments available.*
- c) *Members may elect to pay their annual membership fee in 12 monthly instalments. Fees shall be paid by direct debit and are payable monthly in advance.*
- d) *Monthly membership fees and any pro-rata payments must be paid in accordance with the conditions set out irrespective of actual usage of South Cerney Golf Course.*
- e) *The company may increase membership fees, and shall give the member not less than 30 days written notice of any such increase.*

8. **Expulsion of members and termination of membership**

- a) *The company may terminate the membership of any member:*
 - i. *Without notice and with immediate effect if the member's conduct, whether or not such conduct is the subject of complaint by another member or members, is such that in reasonable opinion of the company, it may be injurious to the character or interests of South Cerney Golf Course, or such that it renders the member unfit to associate with other members of South Cerney Golf Course.*
 - ii. *Without notice and with immediate effect if the member shall have committed any breach of these terms and conditions or of the rules and regulations of South Cerney Golf Course as are from time to time in force.*
All decisions of the company under this clause are final and binding.
- b) *Refunds can not be given for cancellation of annual membership*
- c) *In the event of the death of a member during the currency of his/her membership of South Cerney Golf Course, the obligation to monthly Direct Debit charges shall cease with effect from the date of death.*

9. **South Cerney Golf Course Facilities and Opening Hours**

- a) *The company reserves the right to make reasonable alterations to the types of facilities/special events provided without notice at its absolute discretion and the company shall not be liable for any loss occasioned by such alterations.*
- b) *South Cerney Golf Course's normal hours of operation and the hours in which facilities are available to members are obtainable from the company on request. Such hours may be lengthened or shortened at the absolute discretion of the company with or without any prior notice to members being given. The company shall endeavour to give reasonable notice of any lengthening or shortening of such hours.*
